- b) HEI's are also requested to implement the revised procedure for students to file an online Anti-Ragging Affidavit. Where, the student will receive an e-mail with his/her registration number. The student will forward the e-mail to the Nodal officer in his/her university/college e-mail.
- c) Universities/colleges must display the email address and contact number of the Nodal Officer of Anti-Ragging Committee of their university/college on their website and campus areas like Admission Centre. Departments, Library, Canteen, Hostel, and Common facilities etc.
- d) Universities and Colleges are requested to insert a mandatory column in their university/college's admission form as per the given format:

- e) All HEI's are further advised to fill in the complete details of their respective Anti Ragging Committee and Anti Ragging Squad on the website i.e. [www.antiragging.in](http://www.antiragging.in) and also display these lists on the Notice Boards.
